AMENDMENT TO AGREEMENT FOR RESIDENTIAL AND NONRESIDENTIAL BUILDING DEPARTMENT SERVICES

Mr. Lowe moved, Mr. Everson seconded, to approve amendment 1 to the agreement for residential and nonresidential building department services for Keith Putnam, to include additional services to the Planning and Development Department which is also under the Board of Commissioners, to provide floodplain development inspections, review plans, floodplain management tours on a monthly basis, and aid staff with finding solutions for clients to meet floodplain development standards. The total amount of fees, as revised by this Amendment, payable to the Backup Inspector under this Agreement shall not exceed \$5,000 per year at a rate of \$60.00/Hour. These services provided by the Backup Inspector shall be billed to Ross County Planning and Development Department, Attn: Devon Shoemaker.

BID OPENING RETRO REFLECTIVE PAVEMENT MARKINGS (STRIPING) COUNTY & TOWNSHIP ROADS ROSS COUNTY

Sealed bids were opened at 9:30am as advertised for furnishing and installation of Retroreflective Pavement Markings (Striping) on various County and Township Roads in Ross County. Three bids were received; Ogelsby Construction - \$269,076.80, Aero-Mark Construction LLC - \$241,311.20, J.D. Striping & Sons, Inc. - \$302,224.60. Bids were given to the County Engineers office for review and to award the contract.
