If probable cause is found for the impoundment, the animal will be held at the Humane Society with a cash bond required to hold the animal for 30 days. The bond must be renewed every 30 days until the case is settled or the animal will be forfeited to the Human Society. The Dog Warden and staff will attend Humane Society Agent Training to better understand the legal process.
