## MEMORANDUM OF UNDERSTANDING MASS NOTIFICATION SYSTEM

Mr. Glass moved, Mr. Lowe seconded, to enter into an MOU to provide a mass notification system for the residents of Ross County in times of natural and man-made disasters, local emergencies, and public health emergencies. The City of Chillicothe currently shares twenty-seven percent the cost associated with the current contract that expires on April 30, 2025. The City of Chillicothe agrees to continue reimbursing Commissioners at the current rate. Year one fees will total \$2,904.00 and years two and three will be \$2,634.00.

### AUTHORIZATION TO ENTER INTO NEGOTIATIONS FOR A CONSTRUCTION MANAGEMENT CONTRACT

Mr. Glass moved, Mr. Lowe seconded, to enter into negotiations for a construction management contract with the firm determined to provide the best value by the evaluation committee in accordance with the Revised Code and to accept and approve the best value rankings of the evaluation committee. Projects include: Ross County in partnership with the National Park Service will construct visitor access and experience improvements to four UNESCO World Heritage sites (Hopewell Ceremonial Earthworks) including Mound City Group, Seip Earthworks, Hopewell Mound Group, and Hopeton Earthworks. This project will use the Construction Manager at Risk (CMR) delivery method.

### AMENDMENT NO 1 TO THE ARCHITECT AGREEMENT FELSON PARK PROJECT

Mr. Lowe moved, Mr. Glass seconded, to enter into an Amendment to the Architect Agreement between Orchard Hiltz & McCliment, Inc., dba OHM Advisors and the Board of Commissioners of Ross County, Ohio, specific to the Felson Park project and executed on or about September 9, 2024

- 1. As adjusted by this Amendment, the Basic Services fees to be paid to the Architect are decreased by \$263,605 as outlined below:
- a. Includes Quarry design through Design Development and Construction Documents;
- b. Includes subconsultants geotech, mussel survey, and cultural survey for both Felson and Quarry; and
- c. Assumes designed program elements that are eliminated as a result of VE-budget coordination will be excluded from the construction, and so is excluded from the Construction Administration portion of the A/E fee.
- 2. The total amount of fees payable to the Architect under this Amendment shall not exceed \$727,695.
