CONTRACT SIGNING AEROMARK ROSS COUNTY PAVEMENT MARKING 2026

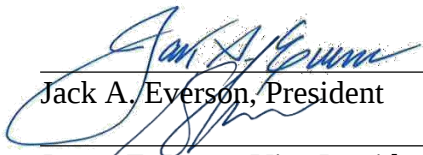

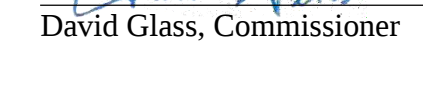
